9. An Update on Planned and Potential New Water Storage Projects for California (Information Item)

Panels representing the U.S. Bureau of Reclamation, the California Water Commission, U.C. Davis, the Association of California Water Agencies (ACWA), the Glenn-Colusa Irrigation District and the San Luis Delta Mendota Water Authority will brief the Council on; (1) the status of several large storage projects identified under the CALFED Program; (2) the public benefits that may be attributed to new storage projects; (3) how to maximize the benefits of new storage projects; (4) the results of a recent water projects survey conducted by ACWA, in cooperation with the CA Water Commission and the Department of Water Resources, and; (5) views of large storage projects and regional storage projects from the perspective of local beneficiaries.
